		The second part of the post from March 2025 to August 2025 is based at the Queen Elizabeth University Hospital (QEUH) OMFS department. The QEUH is the largest acute hospital facility in Europe. The DCT's work as part of the Regional Maxillofacial Unit for adult oral and maxillofacial services. The Maxillofacial Unit is closely allied to Neurosciences and ENT. The post will expose DCT's to all aspects of OMFS including Oncology, Facial Deformity, Paediatric OMFS, Paediatric Congenital Deformity and Trauma. The post will be based in the outpatient and theatre settings. Opportunities for interested candidates to shadow junior medical staff on the ward will exist. These posts require a high level of team-work and good communication skills. An excellent level of support is provided by Specialty Trainees and the Consultant group. DCT's will be allocated to teams within the department to enable them to gain experience in all aspects of OMFS. Weekly teaching takes place at the Queen Elizabeth University Hospital. Applicants should note that travel between hospitals in the Glasgow area may be required for local lists and clinics.  There is no on-call requirement with this post.

These events include all Dental Core Trainees in Scotland, as does the annual DCT conference.

This course is designed to cover the essential skills for an OMFS DCT post and is delivered by OMFS consultants and senior trainees. The teaching is backed up by on-line resources which will made available to DCTs prior to the Maxfacts course
