**PUBLIC SERVICES REFORM (SCOTLAND) ACT 2010** 

# Financial Year ending 31 March 2025 (2024/25)

## **INTRODUCTION**

The Public Services Reform (Scotland) Act 2010 ("the Act") received Royal Assent in April 2010. It contained a number of provisions for the restructuring of Public Sector organisations in Scotland and set up powers for Scottish Ministers to improve the exercise of public functions. It also imposed duties on Scottish Ministers and listed public bodies (including NHS Education for Scotland) to publish information on expenditure and other matters on an annual basis.

### STATEMENT OF EXPENDITURE

The Board is required to provide a statement of any expenditure incurred during the financial year on or in connection with the following matters:

- Expenditure incurred in the financial year on public relations
- Expenditure incurred in the financial year on overseas travel
- Expenditure incurred in the year on hospitality and entertainment
- Expenditure incurred in the year on external consultancy
- Expenditure payments in excess of £25,000 not including remuneration
- The number of employees receiving remuneration in excess of £150,000
- Total remuneration paid to special advisers

#### **Public relations**

The total expenditure on public relations for NHS Education for Scotland for the financial year 2024/25 is £242,689.23

### **Overseas Travel**

The total expenditure for overseas travel for NHS Education for Scotland for the financial year 2024/25 is £143,861.97.

# **Hospitality and entertainment**

There was no spend on hospitality and entertainment for NHS Education for Scotland for the financial year 2024/25.

## **External Consultancy**

The total expenditure on consultancy incurred by NHS Education for Scotland for the financial year 2024/25 is £17,961.99. This was mainly with respect to professional services but excludes audit and legal fees.
