8.	Description of the training post	The Edinburgh Dental Institute based rotation from September 2023 to March 2024 will give the postholder the opportunity to treat patients under local anaesthesia, inhalational sedation and general anaesthesia, with a combination of new patient and treatment sessions. The Paediatric Dental Service runs clinics over several sites and some sessions will take place at other NHS Lothian sites.  In the PDS rotation from March 2024 to September 2024 you will have the opportunity to work in a variety of locations with a range of clinical supervisors where you will provide a range of treatment for PDS patient groups including children and adults with special care needs. This rotation involves travel throughout the Health Board to maximise training opportunity.
9.	Primary Care training element	In this post the DCT1 will work six months in the PDS. You therefore need to be eligible for an NHS List number.

11.	Educational programme summary and library facilities	There is a Scotland-wide education programme for Dental Core Trainees which is designed to match the DCT curriculum. The programme has four themes running through each year of Dental Core Training. These are: Clinical, Communication, Career Development Skills, and Quality Improvement & Patient Safety. Posts begin with a local health board and NES induction, followed by a number of face-to-face study events throughout the year, supported by Turas Learn. These events include all Dental Core Trainees in Scotland, as does the annual trainee conference. All trainees have access to study leave time (in line with terms and conditions of service) and budget. This may be used to access MFDS/MFD/MJDF courses and other courses linked to an agreed PDP. DCT posts include time for self-directed learning and trainees are encouraged to use this time for personal study and to complete quality improvement projects.
